# 1) Qualification Criteria for CII Accredited GreenCo Facilitators

#### 2) Protocols for Accreditation

- A. **Consultants at 'Individual Capacity'** or '**Consulting Firms'** shall submit the following documents to CII for evaluation and further consideration for the Accreditation:
  - i. **For Individuals** -Brief profile of the person, highlighting the eligibility criteria and relevant work experience with a passport size photo

- ii. **For Firms** Brief profile of the firm highlighting the eligibility criteria and relevant work experience along with the documents supporting technical qualification and experience of the professionals
- B. **Professionals who are qualifying in the eligibility criteria shall** undergo " CII Certified GreenCo Facilitator Development Workshop", organized by CII-Godrej GBC annually
- C. After successful completion of workshop, followed by qualifying an online examination; CII will provided a "Course Completion certificate along with accreditation", which will be valid for 3 years
- D. **'Accredited' GreenCo Facilitators** shall participate in the various technical workshops/seminars / training programs/forum meetings etc. as organized by CII-Godrej GBC; to keep them updated about the latest developments in the GreenCo rating.
- E. **Annual Performance Evaluation** will be conducted for the '**Accredited' GreenCo Facilitators**, by CII *based upon the performance in the GreenCo rating projects* handled and feedback received from the facilitated companies. There will be a grading of facilitators based on their performance and capabilities.

## 3) Criteria to participate in GreenCo Activities - Oil & Gas Sector

Consultants at 'Individual Capacity' / Consulting Firms willing to participate in GreenCo activities at O&G sector shall meet the following conditions;

- Technical Qualification & Experience : As mentioned in Sl No. 1 (*prior working experience in O&G sector is preferred*)
- Shall be "CII- Accredited GreenCo Facilitator", with valid certification
- Shall complete 5 GreenCo Assignments (*min*) in other sector (*Engg*, *Auto*, *Chemical*, *Pharma etc*)
- Shall submit the completed GreenCo assignment details to CII-GreenCo Assessment Committee for further consideration





### **Role of CII Accredited GreenCo Facilitators**

The role of the GreenCo Facilitators is to support and provide necessary guidance to the unit in GreenCo Rating as given below:

- Provide training on the GreenCo rating guidelines
- Conduct GAP analysis study with respect to the GreenCo rating guidelines
- Identify opportunities for improvement under the GreenCo rating guidelines
- Develop an action plan for meeting the gaps under the GreenCo rating
- Provide GreenCo documentation support for the unit and prepare for the final onsite assessment
- Identification of applicable regulatory requirements and ensure 100% compliance

GreenCo Facilitators can also provide "Need-based Value-added services "as required by companies to address the gaps under the GreenCo rating guidelines

'Accredited' GreenCo Facilitators shall abide by the all the rules as governed by CII GreenCo Council and shall exhibit highest degree of confidentiality, professionalism, and commitment. Any breach in the aforesaid terms, misrepresentation and violation in any form (Legal or ethical) shall lead to the termination of the 'accreditation' with immediate effect.
