

GreenCo Rating Levels

GreenCo Council

GreenCo Council is a board, comprising of senior representatives & experts from the industry and relevant bodies, that promotes the concept of green companies in the country. The council governs the activities of GreenCo rating and provides the GreenCo certification. The Board's role is to advise and oversee the governance of the GreenCo Rating system and related activities, to ensure the effectiveness for delivering the mission of GreenCo. Eminent leaders from the industry and subject matter experts are invited to be a part of the GreenCo Council. The annual board meeting is conducted every year during GreenCo Summit.

GreenCo Rating

CII GreenCo rating is the first of its kind in the world rating framework that facilities worldclass green companies in the country. launched in 2011, GreenCo rating is a is a voluntary standard developed with extensive stakeholder consultation. The objective is to help companies improve their environmental performance in a holistic manner and move beyond compliance

GreenCo rating adopts a life cycle approach and revolves around 10 performance parameters namely, energy efficiency, water conservation, renewable energy, greenhouse gas emissions, waste management, material conservation, green supply chain, product stewardship & life cycle assessment, innovation and green infrastructure & ecology. A unit or facility is evaluated for a total score of 1000 and rated on five different levels, namely, Platinum (highest), Gold, Silver, Bronze and Certified (lowest).

Assessors, as a part of GreenCo Assessor Panel, shall be at least trained once a year in GreenCo and latest revisions of guidelines

Karnataka State Pollution Control Board has signed an MoU with CII, for promoting GreenCo rating among Industries in the state








BENEFITS ACHIEVED

A total of ₹ 3032 crores of saving has been reported by the GreenCo rated companies until September of 2021. An industry leading payback period of 1.12 years was reported for budget spent on GreenCo and its associated projects.

Green Rating of Industries in Rajasthan

A joint initiative of RSPCB & CII

Rajasthan State Pollution Control Board (RSPCB) & Confederation of Indian Industry (CII), has launched the scheme - 'Green Rating of industries in Rajasthan' in July 2021, the first of its kind in the country. The program is aimed at enhancing and motivating the environmental performance of companies in Rajasthan, thereby enabling them to compete globally, in addition to achieving resource conservation and cost benefits

An exclusive incentive scheme has been introduced for industries in the form of a reduction in consent fees and an increase in the consent period for different levels of rating to encourage performance

Series of awareness programs in different industry sectors were conducted after the launch of RSPCB incentive scheme. Over 300 companies, covering Cement, Textile, engineering and auto sector have been sensitized on the benefits that can be achieved by adopting the GreenCo ratings. Over 50 units have enrolled from Rajasthan for the Green rating scheme since July 2021


KSPCB joins hands with CII in greening the Industries in Karnataka:


GREENCO MOVEMENT

GreenCo Forums

GreenCo Forums are catalysts for the GreenCo movement in the country. The GreenCo Rating System, through its various forums, aims at creating a common platform for industries, to learn from each other and replicate best practices, through one-to-one interactions, presentations, site visits and many more. Every forum meets on a triannual basis. Plant visit of the hosting GreenCo rated company is carried out to understand the GreenCo journey and initiatives taken by the plant. The forums have also actively supported several suppliers and distributors, highlighting their products and services to facilitate green growth of the industry.

GreenCo forum are spearheaded by Industry champions committed to green. GreenCo forum migrated online with 5 successful online forum meetings conducted with 1500+ industry leaders. GreenCo forums are geographically spread across 9 cities in India - Delhi, Mumbai, Pune, Kolkata, Hyderabad, Bangalore, Chennai, Ahmedabad & Indore
