



Carbon footprint - Quantifying the greenhouse gas emissions of organizations, products, and their value chains, providing a clear picture of their environmental impact and a structured roadmap for improvement.



Corporate training programs - Customized, in-house, or virtual programs on various environmental aspects, including energy, water, materials, carbon and waste reduction, green supply chains, life cycle assessment, net zero strategies, ESG and others.



Green and sustainability strategy / roadmap - Collaborate with organizations to develop comprehensive strategy and improvement roadmap for enhancing their environmental performance and achieving green sustainability goals.



Greening the supply chain - supporting organizations in implementing 4key green supply chain strategies and implementation methodologies are developed addressing procurement, logistics, supplier improvement, and others.



Life cycle assessment - Empower companies to assess the environmental impact of their products, processes, and technologies throughout their entire lifecycle.



Net zero / decarbonization strategy - strengthen and accelerate the low carbon journey of organizations and their supply chain thereby facilitating their net-zero transition.


